INTRODUCTORY NOTE: In 1999, the Virginia General Assembly established a "Special Task Force Studying the Ways Faith-Based Community Service Groups May Provide Assistance to Meet Social Needs." Based on the Task Force's recommendations, the state has enacted legislation to include Charitable Choice language in the Virginia Procurement statute; established a toll free phone line to provide technical assistance to FBOs and CBOs; appointed Jane Brown as the "Virginia Community and Faith-Based Initiative Liaison;" established a network of community liaisons and resource contacts throughout the state's 21 local departments of social services and its 26 community action agencies; and sponsored 10 regional skill-building conferences bringing together state and local officials with representatives from FBOs and CBOs.

Despite these impressive steps, the research team found that no one state-level official could provide details about collaborations with faith-based organizations. Most of the information listed below was obtained by contacting the "Charitable Choice Liaison" for each county listed in the "Resource and Liaison Directory: Virginia Community and Faith-Based Organizations" provided by Ms. Brown.

Virginia's actions to spur greater involvement with FBOs is relatively recent. As the information listed below shows, few contracts with FBOs have been executed in Virginia. Although most of the Charitable Choice Liaisons reported some cooperation with faith-based organizations, most of the contacts were informal referrals for help with emergency housing, financial assistance or transportation needs for individuals not meeting the requirements for state assistance, rather than formalized collaborations. A couple of the Liaisons cited reluctance in the faith community to seek government money as a result of the fear of too much paperwork or too many strings attached. Only one Liaison expressed any hostility to the concept of contracting with faith-based organizations, indicating worry about constitutional issues and concern that organizations such as the Aryan Nation would be eligible to compete for government money.

DIRECT FINANCIAL COLLABORATIONS

(1) Northumberland County: Shiloh Baptist Church Tender Hearts for Families

Nature of Service Provided: Mentoring program for Welfare-to-Work, TANF and VIEW clients aimed at helping them achieve self-sufficiency. Help is provided according to the client's needs, including budgeting, parenting skills, nutrition education, etc.

Points to Note: The grant is used to pay the salaries of the director of the program and a clerk/secretary. The church currently has nine volunteer mentors, but is hoping to expand to 20 mentors by May 2002. The church is seeking a TANF grant to expand the program to assist individuals who are seeking work by providing classes to build self-esteem. Sharon Fisher indicated that the program funded is operated separately from the church's religious activities and that participation in religious activities is optional for program participants. Ms. Fisher indicated that no complaints had been received by participants

regarding any pressure to participant in religious activities. Ms. Cottrell indicated that the church and the Department of Social Services were "on the same page" with regard to the issue.

(2) Norfolk Interfaith Partnership

Nature of Service Provided: Mentoring of TANF clients; mentors are recruited from local churches

Amount of Contract: \$62,927 (TANF) This contract followed upon an earlier three-year contract. This contract runs May 2001-May 2002, with a possibility of a two-year renewal. The goal is to provide

mentoring services for 60 clients.

Nature of Service Provided: Goodwill operates an employment program for mentally challenged adults including 10 hours per week for instruction in the classroom teaching work ethics, etc. and 25 hours per week of working in a Goodwill store. It also provides administration of a rehabilitation program which offers employment, training and vocational services to disabled and disad-

vantaged individuals through operation of six thrift stores across Hampton Roads.

INDIRECT FINANCIAL COLLABORATIONS

(1) Newport News: Regional Job Support Network

Nature of Service Provided: The Network provides advice and assistance from volunteer "employment specialists" for TANF recipients within 12 months of reaching their cut-off for cash assistance and for former TANF recipients, to help these clients secure employment or find better jobs. Many of these volunteers are drawn from local congregations. The Hampton Department of Social Services serves as the fiscal agent for the Regional Job Support Network.

NON-FINANCIAL COLLABORATIONS

(1) Lynchburg: Super Cupboard

Nature of Non-Financial Collaboration: Program is aimed at teaching participants budgets, nutrition, shop-

ping and preparing foods. Occasionally, classes are provided to assist participants in finding jobs

and writing resumés.

Points to Note: Interfaith Outreach is an interdenominational non-profit organization with 62 member congrega-

tions, including non-Christian congregations. Interfaith Outreach has run "Super Cupboard" for the past 8-10 years. Participants are referred by the Department of Social Services. Interfaith Outreach has a similar summer program for low-income children called "Kids Café," which teaches about nutrition and cooking skills and helps to build self-esteem and motivation. The programs do not have

a spiritual component.

(2) Gloucester: Lighthouse Worship Center

Nature of Non-financial Collaboration: The Lighthouse Worship Center provides a mentoring program for TANF recipients providing help with job seeking, resume writing, interviewing skills and other skills geared toward helping them find jobs.

Points to Note: The program has been in effect for approximately one year. Social Services initiated the program

and invited the faith community to become involved in providing mentoring to TANF recipients. The Department of Social Services provided training for church members interested in participating in the mentoring program. The program is voluntary and participants sign a release form indicating their willingness to participate in the program. Ms. Council indicated that spiritual issues were intended to be a part of the program. However, Ms. Council indicated that although Social Services has referred clients to the program who have indicated a willingness to participate, the program has not been successful due to a lack of motivation and commitment by clients to follow through with a mentoring relationship. Discussions are currently underway between the church and Social Services to determine how to encourage the clients to participate.

(3) Lexington: Family Mentoring Program

Nature of Non-financial Collaboration: Two churches in Lexington currently are involved in running a mentoring program geared toward helping families who have been on assistance to become self-sufficient.

Points to Note: Referrals to the program are made by the Department of Social Services. A support group including

6-10 church volunteers and a social worker meets every few weeks with mentored families to meet various needs, including transportation, furniture needs, daycare, and financial needs. In addition, the families are assisted with obtaining job skills to secure better jobs and encouraged to get psychological help if necessary. The mentored families are permitted to continue in the program as long as they feel a need. John Winfrey indicated that although the church volunteers are not pushy, "everybody knows it is going to be a church who helps" the mentored family and that the meetings open with prayer. Mr. Winfrey and Gabriella Youngblook both indicated that the main goal of the program is to meet physical needs, however. Mr. Winfrey indicated that his church has a "great working relation-ship" with the social workers involved in the program.

(4) King George: Diaconia

Nature of Non-Financial Collaboration: Forty-three Protestant churches in the area are involved in Diaconia, which provides a mentoring program to address issues such as parenting and finances and also provides assistance for financial needs such as rent, car repairs and electric bills. The recipients of the assistance Diaconia offers are referred by the Department of Social Services.

Points to Note: Mr. Coman indicated that he could not reveal a contact person for Diaconia because all referrals are made by the Department of Social Services as a part of DSS's agreement with Diaconia.

(5) Chesterfield/Colonial Heights: WINGS (Winning Independence Through Nuturing, Guidance and Support)

Points to Note: The Chesterfield/Colonial Heights Alliance for Social Ministries (CHHASM) runs a welfare-to-work project called WINGS which begins with a 17-week in-house program and continues for a three year period with the participants paired one-on-one with a mentor. The goal is to help those who are struggling to become independent after receiving government aid, but does not exclude others who have not received assistance under TANF. The program helps participants set and reach goals in three areas: 1) personal, 2) spiritual and 3) employment.

Participants in WINGS may be referred by the Department of Social Services, but a referral is not a requirement. CHHASM is a 501c3 organization, which Cathy Stevens described as a "ecumenical alliance." The mentors are volunteers from member churches. Cathy Stevens indicated that CHHASM has a "wonderful" relationship with the Department of Social Services. The Chesterfield Board of Supervisors provides CHHASM yearly grants out of county funds to pay part-time personnel, but CHHASM has not received state funding under TANF despite having applied for it.

(6) Charlottesville: Hope Partnership

Nature of Non-financial Collaboration: One year mentoring program aimed at helping participants achieve self-sufficiency.

Points to Note: Hope Partnership assists any families who are striving for self-sufficiency, including those who have been TANF recipients. Teams of 2 to 3 volunteers are paired up with client families for a one-year period, helping those families set and reach goals. The volunteers provide moral support, guidance and assistance in directing the clients to available resources. In addition, they provide assistance with the development of areas such as parenting or budgeting skills. Teams meet with clients at least once a month, and more often if necessary. The Department of Social Services, as well as other agencies and individuals, refer individuals to Hope Partnership. Volunteers currently are members of two local Catholic congregations.

may be eligible to receive from DSS.
