

# WISCONSIN

**INTRODUCTORY NOTE:** *Wisconsin is considered a leader in innovative welfare reform strategies. Its program, "W-2," emphasizes a work-first approach and devolution/privatization, among other features. Wisconsin formally adopted Charitable Choice into state law in 1997. In 1998, the Governor made faith-based subcontracting a key performance indicator for W-2 contractors (i.e., agencies bidding for the opportunity to operate One-Stop Centers under state contract have an incentive to collaborate with FBOs, for they receive points from state proposal reviewers for including such subcontracting ideas in their proposed strategy). The original nine-state Charitable Choice tracking study found Wisconsin active in faith-based contracting under TANF, and this update shows that this trend is continuing. State legislation to establish a faith-based liaison is pending.*
